12/928 SODC and OCC Reports to the Parish Council

Full report at the end of these minutes. They include details of a revised Community Infrastructure Levy Charging Schedule and changes to waste collection dates over the Christmas/New Year period.

12/929 Planning

- a. **P22/S3845/HH-** for development work at Orchard House Aston Upthorpe- Erection of detached garage and pool house. Alterations to Coach House and construction of pond pool. The PC **supports** the proposals but wishes to make the following observations relating to the Coach House. The plans identify changes to the internal structure including the addition of sleeping accommodation and asks if this constitutes a change of use. The PC is concerned at any possible future annexation of the Coach House to form a stand alone dwelling.
- b. P22/S4098/HH- for development work at 1 Alison's Lane Aston Tirrold- Installation of air heat pump and air conditioning unit to living room. Conversion of existing glazed door to a glazed window, with brick beneath. The PC supports the proposals with the following observation. Given the nature of the application, the PC notes the report from MCS in 2019 on likely noise of this small, domestic (as opposed to a larger or more commercial system) heat pump and has assumed that the range identified applies equally in 2022.

12/930 ARC

The minutes from ARC meeting held 6th December were approved. ARC propose placing the new memorial bench for Alan Dodd close to the existing benches on the right as you enter the recreation ground through the kissing gate.

12/933 Silverburn Footpath

In response to a question from a member of the public, JI and PB provided an update of progress since last meeting (including erecting the new kissing gate and fencing at the entrance to the footpath) and JI reiterated that there is currently an exercise to identify all the unregistered land in our villages.

After discussion it was agreed that the PC should spend up to £2,000 to instruct a firm of solicitors (or a Rights of Way consultant) to review the letter from Freeths, Solicitors and to advise the PC on its possible options.

12/934 Demand responsive transport service

OCC has confirmed that the current 94 and 94S bus services will cease running from then end of March 2023.

Government funding has been obtained to run a demand responsive service covering the villages, including ours, south of Didcot for a year from April 2023. This service has yet to be put out to tender, but will be based on a sixteen seater minibus. It is hoped that the service will run throughout the day to reach Didcot Parkway and the Orchard Centre roughly hourly. Seats on the bus will need to be pre-booked by app, email or land line and the bus will only collect or drop off passengers that have booked (and will miss out villages where there are no bookings).

Payment can be made at the time of booking or cards and cash will be accepted by the driver.

The current 94S service will be replaced by a school bus.

Further details will be shared once these are available.

- a) Roads and traffic- OCC has agreed to re-paint the white lines where these have been covered by the recent resurfacing works in Moreton Road and Hagbourne Road.

12/937 Fibre Broadband

Openreach hopes to have connected their new fibre cables to all houses in the villages by late January/early February 2023. The cables currently being laid in Moreton Road are being installed by Gigaclear who intend to eventually offer an alternative broadband service to homes in the villages.

<u>Leaders Statement - 8 December 2022 - South Oxfordshire District Council (southoxon.gov.uk)</u> Recommendations agreed Council:

Adoption of revised Community Infrastructure Levy (CIL) Charging Schedule Following the adoption by Cabinet of the strategy and action plan which would allow the council to pursue a range of options to provide housing, from exemplar schemes to retro-fitting existing homes and bringing empty properties back into use, Council agreed the recommendation to use up to £2m of capital funding to invest in the purchase of property with the aim of them becoming social housing.
