12/856 Planning

- a) P22/S1425/HH- development work at the following location: Winterbrook Cottage 6 Alison's Lane Aston Tirrold. The new homeowner kindly attended the meeting to discuss her plans. The PC agreed that the plans were tastefully done and there was access for the work to be undertaken. Whilst the PC Supports the development makes the following observations: the PC identified concerns relating to the overall increase in size (by circa 20%) to one of the only 2, 2 bedroomed properties within Lower Ham development. Additionally, The PC asked that light spill from the glazed extension be minimised as much as possible.
- b) **P22/S2082/HH** developmental work at the following location: Bagpuize House Baker Street Aston Tirrold for an erection of a two bay replacement garage with home office above. The PC **SUPPORT** this application.
- c) P22/S2130/HH- developmental work at the following location: 1 Edlins Cottages Aston Upthorpe for addition of a dormer window to front elevation, reduce existing dormer to rear and addition of a roof light along with other internal and external alterations. The PC responds to this application making the following observations: the PC supports, but recognises the possibility of excessive light spill from the lantern roof which should be minimised and will be subject to comments from the conservation officer, given that the application identifies this property as a listed building.

- a) Roads and Traffic- community speed watch is still ongoing. The Friday bus has been restarted to Wallingford since May. Only one person has been using it so far so there have been discussions that the service may cease by then end of the month.
- b) Housing and Development- Nothing to report.
- c) Environment Group- NC has created a phase 2 of the village hedgerow and verge management plan with the help from Anna Dillon. NH met with Graham Marcham from SODC, who have acknowledged that Spring Lane is very littered, and they will plan to make this a priority to litter pick. He is also looking into getting some signs and cameras, but they have a concern over the lack of budget for items like this. The PC agreed (subject to quotes) to have the signs installed. It was also reported that 50 bags of cannabis farm waste was also dumped towards the driers.

12/861 Naturist Walkers on Aston Upthorpe downs

22 naturist walkers were spotted taking a hike last week. While it may seem intimidating to some, it is not illegal. JI sought advice from Friends of the Ridgeway along with the Ridgeway Officer. This is not an offence. She will also contact our local PCSO's to make them aware.
