12/900 Planning

a) P22/S2217/HH- for development work at 2 Aston Street Aston Tirrold. To erect a rear extension and works to existing detached shed including new roof- The PC has no strong view on this application but would like to make the following and, in its view, material observations. The application had been plagued by delay due to the lack of and poor quality information being submitted for consideration. Whilst that now seems to have been resolved with the amended plans, the PC would wish to add that in its view, the documentation still falls short of what would be expected. The amount of work undertaken prior to full approval being granted (despite the applicant seeking preplanning advice) has caused considerable issues for villagers and the Parish Council.

12/903 CLP Groups

- a) Roads and traffic-
 - Averaging one speed watch per week.
 - The Friday bus service restart is being deferred until the new year should the need for it to restart arise. OCC might replace the 94 bus with a request bus SY will follow this up to see if the Astons could be included in the route.
- b) Housing and Development-
 - A letter has been forwarded to Adrian Duffield Head of planning services at SODC regarding the decision notice comments on planning application P/21/S4995 relating to the assumption made on sustainability. A response is awaited.
 - Orchard house have emailed the PC to inform them that a brick pillar and part of the wall have been removed to allow lorries easier access to the site. The wall and pillar will be reinstated 'as it' once the works are completed.

c) Environment Group-

Hedgerow and verge management plan

- The Hedgerow and verge management plan is complete, it is just waiting on a map from the council which shows the areas they maintain. As this has been something that has been sought after for a long time the thought of listing roads they cover instead for now would suffice. This will provide a clearer picture of what Rustic Management maintain. A one page short summery to go on front of the Astons news outlaying householder's and owner's obligations to maintain their hedges and verges.
- Bi-yearly or quarterly competitions to be run to get the younger generation engaged.
- The PC will add verge and hedge checks twice a year to the calendar tasks.
